The King and Queen and Supreme of the Seas are titles that are voted on by the attendee's present at the event. The categories are Theme Presentation, Performance, Formal wear/Question & Answer.

COURT OF SEATTLE - MISSION STATEMENT

The Court of Seattle Organization dba The Imperial sovereign Court of Seattle & the Olympic and Rainier Empire, Inc. is a 501©(3) non-profit social/charitable organization. Our purpose is to provide funds and services to other non-profits within the communities of Seattle throughout King and Island counties. Our organization strives for acceptance and equality for all citizens erasing hate, denigration and degradation resulting in enhancements to our communities near and far.

QUALIFICATION REQUIREMENTS:

Anyone wishing to run for any of the following elected positions within the organization must meet the qualifications, as set forth below. Titles are individual, and only one (1) person can hold any elected title--precluding such situations as "Co-Emperor," "Co-Queen," etc.

- a. Complete an application for the position of the Seas. All applications are to be received by the start of the Pageant.
- b. Pay a non-refundable filing fee, as determined by the Board of Directors;
- c. Be eligible for membership in the Court;
- d. Not be a reigning titleholder in this or any other Empire;
- e. Provide such documentation as necessary to substantiate eligibility and qualifications as set forth in this section.
- f. Must join the Court within 30 days of ascension to the title and must remain a member in good standing during the reign.

VOTING FOR THE KING/QUEEN/SUPREME OF THE SEAS: Voting for these positions will take place at the location of the appropriate function between the hours designated by the Board. Voting will be open to anyone in attendance. Tabulation of the ballots will be the responsibility of the Board President and the Board of Directors. Anyone counting the ballots must maintain confidentiality and not disclose the results before they are publicly announced.

ATTENDANCE: 1. Attend all Court Meetings, and maintain membership in good standing in the court; 2. Represent the Organization at all official Court-sponsored, Court-sanctioned, and Court-endorsed functions as able; and 3. Attendance is required at Coronation and the major pageants of the ISCSORE (IP, Hearts, Seas, Seattle, Closet Ball).

FUNCTIONS TO PRODUCE: *These titles shall be responsible for assisting in the planning, execution, and success of those Court functions as requested by the Monarchs. It is required that they host and plan at least two fundraisers during their year for which 50% of the proceeds will be designated for the Court General Fund and 50% designated for the Court Scholarship Fund.*
